

Tennessee, and Amtrak to bring back our passenger service!

KYPath proposes Amtrak operate a new "Bluegrass Line" on existing track Cincinnati to Atlanta, with stops in Lexington, Knoxville, and 18 other towns.

Day & night trains should run each way each day, quick as driving. Amtrak coach tickets are competitive with the cost of gas.

# Where will The Bluegrass connect?

- In Cincinnati, Amtrak's New York to Chicago Cardinal train (Philadel-phia, Washington, Charlottesville, Charleston WV, Indianapolis)
- In Atlanta, Amtrak's New York to New Orleans Crescent train (Charlotte, Birmingham)
- In Winchester, the proposed restored EK line (Irvine, Beattyville, Jackson, Hazard)
- From Cincinnati, Knoxville, and Atlanta, fly or take Greyhound or charter buses

Amtrak & state support follow local support.
